LEAF Scholarship Application

Thank you for your interest in applying for a LEAF Scholarship.

1. Any student attending an accredited California community college or state university majoring in a landscape-related program and taking a minimum of six units is eligible. Certificate programs are not eligible for funding.
2. Scholarships are available for students who will be continuing at their current college or who will be transferring to another accredited college in the fall of 2019. Recipients will receive the actual funding only with official proof of enrollment for the fall semester.
3. Three letters of recommendation are required. One of these three letters must be from a current instructor or counselor. The other two can be from a current or recent employer, club/activity advisor, previous instructor or church leader.
4. A copy of your college transcript(s) from each college attended is required.
5. Applications will be independently reviewed by the members of the CLCA Auxiliary Scholarship Selection Committee. Criteria includes career goals, extra curricular activity, work experience, financial need and letters of recommendation. Scores will be tallied and recipients chosen accordingly.
6. Any information submitted (application information, employment, letters of reference, etc.) may be verified.
7. Mailed applications must be postmarked by April 15, 2019. Electronic applications must be received by April 15, 2019. No extensions.
