

2021 CLCA Convention COVID-19 Safety Procedures and Waiver

SAFETY PROCEDURES

California Landscape Contractors Association (CLCA) is committed to providing a safe and healthy environment for all 2021 CLCA Convention participants. Our decisions and preventive measures will be guided by the requirements and recommendations of the U.S. Centers for Disease Control (CDC) and federal, state, and local health authorities. We are working with Westin Maui Resort and Spa on implementing preventative measures to reduce the potential spread of the COVID-19 virus at our 2021 CLCA Convention. **Required preventive measures include:**

- Mask wearing at all indoor events and on all buses for off-site tours;
- Proof of vaccination or negative PCR test within 72 hours of arrival;
- Enhanced sanitization of meeting and event spaces;
- Social distancing;
- Hand sanitizing stations throughout the meeting space; and,
- Other, as needed or specified by CLCA and the Westin Resort.

The responsibility for a safe and healthy event environment is shared among the event organizer, venues, and every participant. All 2021 CLCA Convention participants are expected to adhere to and abide by the safety precautions CLCA is implementing to protect against the spread of COVID-19. **You may not attend the 2021 CLCA Convention if you:**

- are experiencing, or within the 10 days prior, have experienced signs and symptoms of COVID-19;
- believe that you may have been exposed to a confirmed or suspected case of COVID-19;
- share a room or hotel space with a person who has a confirmed or suspected case of COVID-19;
- or,
- have been diagnosed with COVID-19 and are not yet cleared as non-contagious by the health care team responsible for your treatment.

If you (or another individual sharing your hotel room, if applicable) experienced signs and symptoms of COVID-19, you will not be allowed to attend any CLCA events until you receive a negative PCR test.

Conference attendees should self-monitor for signs and symptoms of COVID-19 and are asked to contact CLCA if they experience symptoms of COVID-19 within 10 days after the 2021 CLCA Convention. Should any positive cases be reported within the 10-day timeframe, CLCA will communicate this information to all registered participants. Any private health or personal data received by CLCA will be treated as confidential.

ATTENDEE LIABILITY WAIVER AND ASSUMPTION OF RISK

By signing below, you acknowledge the highly contagious nature of COVID-19 and voluntarily assume the risk of exposure or infection by attending the event, and that such exposure or infection may result in personal injury, illness, disability, and/or death to attendee. You understand that the risk of becoming exposed to or infected by COVID-19 at the event may result from the actions, omissions, or negligence of others who may attend the event or their families, colleagues, or others with whom they may have contact. Accordingly, you understand and agree that this release includes any claims based on the actions, omissions, or negligence of California Landscape Contractors Association, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the event.

In addition to all other rules and regulations relating to your attendance at the event, you agree to comply with all COVID-related procedures that may be implemented by CLCA and the Westin Resort, including, but not limited to, vaccinations or negative COVID-19/PCR testing, mask-wearing, and social distancing requirements and restrictions on certain activities that carry higher COVID-19 related risk, in order to protect as much as possible, the health and safety of all event attendees.

You further understand that refusal to adhere to these policies and abide by these precautions may result in immediate removal from the event and cancellation of the registration, without receiving a refund.
